The 22nd Judicial District Court has just issued the following court orders. We had a meeting yesterday with all of our partners in the justice system from both Washington and St. Tammany Parishes, including the Clerks of Court, the District Attorney, the Sheriff's Department and representatives of law enforcement throughout the parishes, the St. Tammany Assessor, the St. Tammany Parish President's representatives, representatives of other court related agencies, together with our Judges, the Commissioner and Judicial Administrator.
